TOURNAMENT RULES AND INFORMATION

ENTRY DEADLINE – APRIL 26, 2021

- 1. ENTRANT/PARTICIPANT REQUIREMENTS: ALL TEAM CAPTAINS MUST REPORT TO THE TOURNAMENT OFFICE AT LEAST ONE HOUR PRIOR TO SCHEDULED BOWLING TIME.** BOWLERS MUST HAVE A USBC CARD PURCHASED IN WEST VIRGINIA. THOSE WITHOUT USBC CARDS MUST: A) PROVIDE WRITTEN CONFIRMATION FROM THEIR LOCAL SECRETARY/ASSOCIATION MANAGER, OR B) PAY \$24.00 FOR A CARD TO BE REFUNDED UPON CONFIRMATION OF MEMBERSHIP. NO MORE THAN TWO BOWLERS WHO ARE MEMBERS OF OR HAVE APPLIED FOR MEMBERSHIP IN A PROFESSIONAL BOWLING ORGANIZATION CAN BE ON A 4-PERSON TEAM AND ONLY 1 ON A DOUBLES TEAM. **YOU MUST HAVE A 21 GAME AVERAGE FROM AN ADULT LEAGUE AND MUST BE AT LEAST THE AGE OF 18 AT TIME OF ENTRY.** THIS TOURNAMENT IS USBC CERTIFIED.
- 2. BOWLING OPPORTUNITIES:** A BOWLER MAY COMPETE TWO (2) TIMES IN THE TEAM EVENT OF THIS TOURNAMENT. NOT MORE THAN TWO (2) BOWLERS ON THE SAME TEAM MAY PLACE MORE THAN ONCE IN THE PRIZE LIST FOR POSITION STANDINGS. A BOWLER'S FIRST TEAM AND FIRST DOUBLES/SINGLES EVENT SCORE WILL COUNT FOR ALL-EVENTS. A BOWLER MAY COMPETE TWO (2) TIMES IN THE DOUBLES AND SINGLES EVENTS. THE PENALTY FOR AN INFRACTION OF THIS RULE IS DISQUALIFICATION AND FORFEITURE OF ENTRY FEES AND PRIZE MONEY IN THE EVENT IN WHICH IT OCCURS. ONLY SUBSEQUENT APPEARANCES ARE SUBJECT TO ANY DISQUALIFICATION AND FORFEITURE OF ENTRY FEES AND PRIZE MONEY. ALL BOWLERS ENTERING THE DOUBLES MUST ALSO BOWL IN THE SINGLES EVENTS. ALL BOWLERS ENTERED IN THE TEAM, DOUBLES AND SINGLES EVENTS MAY PARTICIPATE IN THE ALL- EVENTS BY PAYING THE SUM OF FIVE DOLLARS (\$3.00) PER ENTRANT. ANY BOWLER WHO PLACES FIRST IN THE ALL-EVENTS BUT HAS NOT PAID THE ALL- EVENTS FEE IS ELIGIBLE TO RECEIVE ONLY THE NON-CASH CHAMPIONSHIP PRIZE FOR THE ALL-EVENTS. ALL - E V E N T S I S A N A C T U A L / S C R A T C H O N L Y .
- 3. SUBSTITUTES:** SUBSTITUTES WHO MEET ELIGIBILITY STATED IN RULE 1 MUST REPORT TO TOURNAMENT MANAGEMENT ONE HOUR PRIOR TO A SCHEDULED SHIFT.
- 4. ENTERING AVERAGES:** ENTRANTS WILL USE THEIR 2019-2020 HIGHEST USBC LEAGUE AVERAGE OF 21 OR MORE GAMES. IF NO AVERAGE LAST YEAR, USE HIGHEST CURRENT SEASON 2020-2021 USBC AVERAGE AS OF MAR 1, 2021 FOR 21 OR MORE GAMES. ENTRANTS WITH NEITHER OF THE ABOVE AVERAGES MUST BOWL SCRATCH. **IT IS EACH BOWLER'S RESPONSIBILITY TO VERIFY THE ACCURACY OF HIS/HER OWN AVERAGE IN A HANDICAP TOURNAMENT, REGARDLESS OF SOURCE.** FAILURE TO USE THE CORRECT AVERAGE WILL DISQUALIFY THE SCORE IF SUBMITTED AVERAGE IS LOWER THAN CORRECT AVERAGE, THEREBY RESULTING IN MORE HANDICAP. THIS INCLUDES ANY SPORT OR CHALLENGE AVERAGES ALSO. PRIZE WINNINGS WILL BE BASED ON THE SUBMITTED AVERAGE, IF IT IS HIGHER THAN THE CORRECT AVERAGE. (RULE 319A, ITEM 3). **WHEN PREVIOUS SEASON'S AVERAGE IS USED, AND AS OF MARCH 1, 2021, AN ENTRANT HAS A CURRENT AVERAGE FOR 21 OR MORE GAMES THAT IS 10 PINS OR MORE HIGHER THAN THE PRIOR SEASON'S AVERAGE, THE CURRENT AVERAGE MUST BE USED.**
- 5. AVERAGE RERATING:** THIS TOURNAMENT ENFORCES USBC RULE 319. THE AVERAGE OF A BOWLER MAY BE ADJUSTED UPWARD BEFORE PARTICIPATION IN ANY EVENT. IF THE ASSIGNED AVERAGE IS NOT ACCEPTED BY THE BOWLER, THE ENTRY FEES SHALL BE REFUNDED.
- 6. REPORTING OF PREVIOUS TOURNAMENT WINNINGS WILL APPLY (RULE 319D). THE AVERAGE ADJUSTMENT RULE WILL APPLY (RULE 319E). FAILURE TO COMPLY ON EITHER RULE IS CAUSE FOR FORFEITURE OF ENTRY FEES AND PRIZE WINNINGS.**
- 7. HANDICAP PERCENTAGE USED:** THE HANDICAP WILL BE 90% OF 225 PER BOWLER.
- 8. PRIZES:** AWARDS WILL BE GIVEN TO THE HANDICAP WINNERS IN THE TEAM, DOUBLES, SINGLES, AND SCRATCH ONLY ALL-EVENTS. PRIZE FEES ARE RETURNED 100% IN CASH AND PRIZES. PRIZE WINNERS ARE BASED ON THE FOLLOWING ENTRY RATIOS: AT LEAST ONE IN FIVE (1:5) IN TEAM, DOUBLES, AND SINGLES. AND AT LEAST ONE OUT OF TEN (1:10) IN SCRATCH ONLY ALL-EVENTS.
- 9. DRESS CODE:** BOWLERS SHOULD LOOK PRESENTABLE. NO CUT OFFS, SLEEVELESS TOPS, SHORT SHORTS. ANY BOWLER APPEARING TO BOWL IN VIOLATION OF THIS DRESS CODE WILL NOT BE PERMITTED TO BOWL AND THERE WILL BE NO REFUND OF ANY ENTRY FEES. ANY BOWLER WHO VIOLATES THIS RULE DURING TOURNAMENT PLAY WILL BE DISQUALIFIED AND FORFEIT ALL ENTRY FEES AND PRIZES.
- 10. OTHER:** TOURNAMENT MANAGEMENT WILL SCHEDULE LANE ASSIGNMENTS FOR EACH EVENT. IN THE DOUBLES & SINGLES EVENTS, DOUBLES WILL BE BOWLED FIRST, FOLLOWED BY SINGLES. **THE TOURNAMENT DIRECTOR WILL ALLOW TEAMS TO BE PAIRED IF REQUESTED AND ENTRIES ARE SUBMITTED TOGETHER.** ENTRIES SHALL BE MAILED WITH A MONEY ORDER OR BANK CHECK FOR THE TOTAL AMOUNT. ENTRIES MUST BE POSTMARKED BY MIDNIGHT **APRIL 26, 2021.** **TWO (2) TEAMS WILL BE ON EACH PAIR OF LANES, AND A MINIMUM OF TWO (2) SETS OF DOUBLES WILL BE ON EACH PAIR OF LANES. LANES WILL NOT BE SKIPPED BETWEEN TOURNAMENT BOWLERS.** ALL DECISIONS OF THE TOURNAMENT MANAGER ARE FINAL UNLESS AN APPEAL IS MADE IN ACCORDANCE WITH USBC RULE 329.
- 11. LATE ENTRIES:** LATE ENTRIES MAY BE TAKEN UP TO **MAY 1, 2021** PRIOR TO THE START OF THE TOURNAMENT. THERE WILL BE AN ADDITIONAL **\$25.00** CHARGE FOR APPLICATIONS SUBMITTED AFTER APRIL 26, 2021. **NO ENTRIES ACCEPTED AFTER POSTMARK DATE OF MAY 1, 2021!!! NO EXCEPTIONS!!!** IF ENTRY IS POSTMARKED AFTER **MAY 1, 2021**, IT WILL BE RETURNED TO YOU.
- 12. CDC RULES FOR COVID WILL BE IN EFFECT AT ALL TIMES. MASKS MUST BE WORN AT ALL TIMES UNLESS EATING, DRINKING OR ON THE APPROACH. EACH BOWLER WILL BE LIMITED TO ONE SPECTATOR EACH. TOURNAMENT IS SUBJECT TO CHANGE**
