2022 West Virginia State USBC Pepsi-Tournament Rules

1. WV State USBC Pepsi Championship is certified (cert #04565), all USBC rules and regulations will be in effect.
2. **Bowler must be a USBC youth member, and bowl in a WV USBC certified youth league. Bowler needs to have 21 games to bowl in the Pepsi.**
3. **Competition:** Qualifying March 12, 2022 Squad times 9:00 am & 1:00 pm. Finals on March 13, 2022.
4. **Squads times will be added if needed.**
5. Competition shall be conducted in the following males and female division. (March 13, 2022 is only the top 24.) By ages as of 8/01/2021.
6. Symbolic awards 1st, 2nd, 3rd and 4th in all divisions (U8, U10, U12, U15, and U18).
7. All bowlers must wear proper attire. Dress code: **NO** shorts above the kneecaps, **NO** wearing of clothing depicting foul language or gestures. **NO** hats allowed. **NO** smoking or drinking of alcohol in the center. **NO** cell phone, **NO** ear buds, **NO** hitting, kicking, or foul language or gestures.
8. No entry fee will be returned after tournament closing date!!
9. **Tournament Format:** Bowlers in U8, & U10 will bowl a 3-game series without advancement.
10. Divisions U12, U15, & U18 will bowl a 3-game series.
The top 24 will go on, if there is a tie for 24th place. Will bowl 9th and 10th frame roll-off, with the highest game in the series picks start 1st or finish 1st.
After advancing to the top 24 all pin fall from the previous games will be dropped.
Any division that does not have a required minimum number of bowlers will advance to next round. The top 6 will compete in a 5 game round robin format. Each bowler will bowl 1 game against each bowler in the Top 6. Each bowler will move a pair of lanes to the right after each game. Each bowler will bowl 1 game on each pair used for their age division.
The winner of each match will receive 30 bonus points for winning the match. At the end of the 5 game round robin total pins plus bonus points will determine the final standings of the tournament.
11. **Finals are on March 13, 2022 @9:00 am sharp. (With the exception of the smaller groups possibly bowling Saturday evening.)**
12. Scholarship fee returned 100% Scholarship will be awarded as follows: all divisions 1 out of 10. Scholarship will be held in the **USBC SMART FUND #0552**
13. Competitors will be allowed 10 minutes of practice on both of their starting lanes. Bowlers and officials only allowed in the seating area. **Coaching is permitted but BOWLER must come back to the coach or parent on the carpet area.**
14. Bowler(s) arriving late shall begin play and score shall count beginning with that frame then being bowled. Missed frames shall be credited with a zero. Bowler(s) not present to bowl when it's their turn will be credited with a zero for that frame.
15. Only bowlers, score keepers and tournament officials will be allowed in the immediate bowling area.
16. Claims for errors in scoring or general playing rules must be given to the tournament director no later than the start of the block or 30 minutes after the completion of competition. Questionable errors shall be decided by the tournament director. All other protests must be submitted in writing to the tournament director before the awards are presented. Under this rule, each protest must be specific in itself.
17. The First-place winners of the **U12, U15, and U18** divisions for both Males and Females will advance to the 2021 Junior Gold Championships on July 11-15, 2022 @ Michigan. They must be **USBC Junior Gold** members to advance to the Junior Gold Championships.
18. Bowlers without a current Junior Gold membership **MUST** purchase a Junior Gold membership prior to June 1st. USBC will waive the \$200 U18 and U15 and \$100 U12 entry fee. These athletes will compete for additional scholarships available to all athletes at the championships, and international competition.
19. If the **U12, U15 and U18** Division Champion is unwilling or unable to become a Junior Gold member they will not advance to the Junior Gold Championships. However, the athlete will still retain the State/zone scholarship, but the spot to the Junior Gold Championships will be awarded to the next eligible athlete. Travel expense for 1st place winners will come from the ball raffles, and fund raisers. Eligible advancers must agree to bowl in the Junior Gold Championships, or failing to do so, agree to waive all rights. Replacements will be selected based on the order of finish in their division at the state/zone level. Replacements will occur all costs associated with changing airline ticket, if applicable.
20. **Tournament Director is responsible for verification of memberships.**
21. The tournament director has the right to disqualify a bowler if he or she violates **USBC RULE 17d.**
22. **All Bowlers in the Host Zone MUST bowl the FIRST squad!**
23. The WV State USBC board of directors will decide any questions not covered by these tournament rules.
